3. Inappropriate language or conduct, toward other vendors, customers, or managers will not be tolerated and may result in suspension from the Farmers' Market. Such suspension will be at the discretion of the Columbia Falls Farmers' Market Committee and the Market Master.

4. The applicant assigns all rights and releases from liability the Columbia Falls Farmers' Market Committee of The First Best Place Task Force, its members, its officers, employees, agents and sponsors and assigns, and all other persons, firms, or corporations liable or who might be claimed to be liable, none of whom admit any liability to the undersigned, but all expressly deny any liability, from any and all claims, demands, damages, actions, causes of action, or suits of any kind or nature whatsoever, and particularly without limitation on account of all injuries or claims, known and unknown, both to person and property, which may result or may in the future develop from any activities taking place in connection with the activities contemplated hereby.

5. The applicant hereby indemnifies and agrees to defend and hold the Organization and its sponsors harmless from and against any claims, demands, loss, damage, or expenses resulting from the negligent acts or omissions of the Organization that may result in connection with the activities contemplated hereby or in the future may develop from any such activities.

I understand that it is my responsibility to make sure that anyone working with me at the Farmers' Market has read and understands this agreement and the Columbia Falls Farmers' Market Rules.

Columbia Falls Farmers Market Rules

Items accepted at the Columbia Falls Farmers market will be locally grown or hand made. The exception to this rule is the Columbia Falls Library Association. Determination of suitability will be made by the Market Master or a majority of the Farmers Market Committee.

Market will be Thursdays beginning June 17 and the last Market will be on Sept. 30.

A signed copy of the Vendor Registration form is required before setting up.

Set up time: 3:30 p.m. – 5:00 p.m. Must be set up by 5:00 and remain set up until 7:30 p.m. unless permission is given by the Market Master to arrive or leave at an abnormal time.

Please check in with the Market Master for space assignments or before setting up. Vendors participating every week will have reserved space. Reserved space not occupied by 4:30 (or notifying us of late arrival) will be reassigned.

The Vendor will provide their own table, chair, display and any other equipment they need. Spaces are approximately 10 feet by 10 feet. The Market Master may access and additional space charge of 5% per space for Vendors using more than allotted space. The additional charge is wholly at the discretion of the Market Master.

Please pay the Market Master 5% of your total sales before you leave the market.

A small number of electric outlets are available on a first come first served basis. A vendor using electricity will pay a \$5 fee per week in addition to the 5% of total sales.

Vendor is responsible for complying with any City, County, State or National laws, permits, or licenses required by said entities.

The Vendor agrees to keep their space clean and neat during the market. This includes providing your own garbage can if you are selling products that generate waste.

Vendor space and surrounding area will be cleaned up by the Vendor before leaving the market.

All problems and conflicts should be directed to the Market Master who will have the final say in conflicts or disputes. If appropriate, problems will be considered by the Market Committee and settled by majority vote.

Please move your vehicle to the parking lot behind the Columbia Bar or at least two blocks away from the market so we have plenty of customer parking. Failure to move your vehicle will result in eviction from the market.
